

Third Party Privacy Notice

INTRODUCTION

This Privacy Notice ("**Privacy Notice**") explains what personal data Encyclis Limited ("**Encyclis**", "**we**", "**us**", "**our**") collects about visitors to Encyclis sites, contractors working at or with Encyclis, and other individuals with whom we may have a business relationship, what we will use it for and with whom we share that information. This Privacy Notice also sets out your rights and who you can contact for more information. Please read the following carefully to understand our views and practices regarding your personal data and how we will treat it.

Encyclis is a data controller of your personal data, which means we decide how to process your personal data and have certain responsibilities in relation to your personal data. Personal data means any information that can be directly or indirectly related to you.

In this Privacy Notice the term "**Data Protection Legislation**" means all applicable legislation relating to privacy or data protection in force from time to time, including the EU General Data Protection Regulation ("**GDPR**") and the GDPR as it forms part of the domestic law of the United Kingdom.

WHO DOES THIS PRIVACY NOTICE APPLY TO?

This Privacy Notice applies to:

- **Encyclis site visitors:** individuals who visit Encyclis sites, including Encyclis offices and Encyclis plants.
- **Encyclis contractors:** individuals working at or with Encyclis as contractors, or individuals who are employees or otherwise represent contractors working at or with Encyclis.
- Any individuals with whom we may have a business relationship: which may include suppliers of Encyclis, or employees or other representatives of Encyclis suppliers with whom we have a business relationship, and employees or other representatives of Encyclis customers with whom we have a business relationship.

References to "**you**" and "**your**" are references to Encyclis' site visitors, contractors or any other individual with whom we may have a business relationship.

CHANGES TO THIS PRIVACY NOTICE

Any changes we make to this Privacy Notice in the future will be posted on this page on the Encyclis website. We strongly encourage you to check this Privacy Notice from time to time. However, any material changes to this Privacy Notice will be notified through an appropriate method.

HOW WE COLLECT YOUR PERSONAL DATA

We collect and process personal data directly from you or which we gather about you during the course of your relationship with Encyclis.

Where the personal data we process is collected from you, its provision to us is generally required in order to maintain our relationship with you or to allow you to visit our sites. In some cases it may mean we are unable to continue our relationship with you, or unable to allow you

on-site, as Encyclis will not have the personal data we believe necessary for the effective and efficient administration and management of our relationship with you or to manage site visits.

You may also provide us with personal data of third parties. By providing us with such personal data you confirm that you have informed these third parties of what data you intend to provide to Encyclis and the processing carried out by Encyclis, as detailed in this Privacy Notice.

PERSONAL DATA WE COLLECT

The personal data we process may include:

Business Contact Data	Your name and work contact details; any other details that you may choose to provide to us.		
Business Financial Data	Bank account information.		

Under Data Protection Legislation, special categories of personal data include data revealing racial or ethnic origin, political opinions, religious or philosophical beliefs, or trade union membership, and genetic data, biometric data, data concerning health or data concerning a person's sex life or sexual orientation.

Some of the personal data that Encyclis holds about you are deemed special categories of personal data under Data Protection Legislation (for example, any health data included in

Visitor Incident Data or Contractor Incident Data, and Contractor Health Data is special category personal data). Encyclis will usually only process these special categories of personal data to manage any incidents that occur on site or, for contractors only, to conduct inductions.

HOW WE USE YOUR PERSONAL DATA

Data Protection Legislation requires that we process your personal data for purposes that we tell you about and only where we have a lawful basis to do so. The below table sets out our purposes of processing, the lawful basis of processing we rely on, and the personal data processed for that purpose.

SHARING YOUR PERSONAL DATA

Encyclis may disclose your personal data to the following categories of third party recipients where we consider it necessary for the purposes set out in this Privacy Notice:

- Encyclis affiliates.
- Third parties who provide various services to us in connection with our relationship with you or any other related purposes (such as IT service providers, or third parties who provide access and security services in respect of our sites).
- Professional advisors, such as accountants, lawyers or auditors.
- Regulators or other authorities or third parties to comply with the law or assist in a criminal or regulatory investigation, or to protect us (for example, to help prevent fraud or protect or enforce our rights).
- Other parties as part of a corporate transaction, for example if it is proposed that we are to merge with or be acquired by another business in the future.

HOW WE PROTECT YOUR PERSONAL DATA

Encyclis takes all reasonable steps to keep your personal data secure and confidential. In particular, we maintain appropriate physical, organisational and technical measures so as to prevent any loss, misuse, unauthorised access, disclosure, or modification of your personal data.

HOW LONG WE KEEP YOUR PERSONAL DATA

We will only keep your personal data for as long as it is required for the purposes for which it was collected, or as required to comply with applicable law or to defend or enforce our legal rights.

OVERSEAS TRANSFERS OF YOUR PERSONAL DATA

We may transfer your personal data to a recipient based in a country outside of the UK and/or European Economic Area ("**EEA**"). Where we do so, we will ensure that such transfer is in accordance with our obligations under Data Protection Legislation.

For example, this may involve transferring your personal data to a jurisdiction deemed to provide an adequate level of protection of your personal data by the UK and/or European Commission. Other times, the recipient may be in a jurisdiction which has less stringent laws relating to personal data. In these circumstances, Encyclis will put in place appropriate safeguards to ensure that your personal data remains adequately protected, which may include entering into appropriate standard contractual clauses with the recipient of the data such as the International Data Transfer Agreement or the EU Standard Contractual Clauses alongside, where applicable, the UK Addendum to the EU Standard Contractual Clauses.

YOUR RIGHTS IN RELATION YO YOUR PERSONAL DATA

You have various rights in relation to the personal data we hold about you. These include:

- to request access to or a copy of any personal data which we hold about you;
- to rectification of your personal data, if you consider that it is inaccurate or incomplete;
- to erasure of your personal data, if you consider that we do not have the right to hold it;
- to restrict processing of your personal data;
- to data portability (moving some of your personal data elsewhere); and
- to object to your personal data being processed in a particular situation, which you may exercise if we rely on the fact that the processing is necessary for the purpose of legitimate interests pursued by Encyclis in order to carry out that processing.

Where we rely on consent to process your personal data, you also have the right at any time to withdraw any consent you give to our processing of your personal data.

Any request for access to or a copy of your personal data must be in writing and we will respond within any time limits provided for in Data Protection Legislation.

However, please note that some of these rights may not always apply, as there are sometimes requirements and exemptions which may mean we need to keep processing the personal data or not disclose it, or other times when the rights may not apply at all. We will always tell you if we think we do not have to comply.

RIGHT TO COMPLAIN

You also have the right to complain to the regulator about Encyclis' information rights procedures.
